**ORDER**

**AND NOW**, this 3<sup>rd</sup> day of June, 2022, upon consideration of *Plaintiffs' Complaint and Plaintiffs' Emergency Petition for Temporary Restraining Order and Special Preliminary Injunction*, and any response thereto, and the testimony, arguments and evidence that had been tendered during the evidentiary hearing held before this Court on June 3, 2022, it is hereby **ORDERED** and **DECREED** that the Plaintiffs' have demonstrated the need for this Court's emergency intervention and relief, and the *Plaintiffs' Emergency Petition for Temporary Restraining Order and Special Preliminary Injunction* is **GRANTED IN PART AND DENIED IN PART** as follows:


1. Defendants/Respondents Chairman Robert A. Brady and the Philadelphia County Democratic Party Executive Committee shall specifically direct the 22<sup>nd</sup> Ward Democratic Executive Committee, including its current Ward Leader Cindy Bass, to provide advance reasonable notification, permit and promote attendance and full participation, including voting, of all duly elected 22<sup>nd</sup> Ward Democratic Committee persons at all future meetings of the 22<sup>nd</sup> Ward Democratic City Committee including the organizational meeting which is scheduled for June 6, 2022;
2. Defendants/Respondents, the 22<sup>nd</sup> Ward Democratic Executive Committee, including its current Ward Leader Cindy Bass, shall provide advance reasonable notification, permit attendance and promote full participation

including voting rights of all duly elected 22nd Ward Democratic Committee persons at all future meetings of the 22nd Ward Democratic City Committee including the organizational meeting, which is scheduled for June 6, 2022;

3. Defendants/Respondents, the 22<sup>nd</sup> Ward Democratic Executive Committee, including its current Ward Leader Cindy Bass, are directed to cease and desist from excluding duly elected members from attending and fully participating and voting of duly elected 22nd Ward Committee persons at all future meetings of the 22nd Ward Democratic City Committee including the organizational meeting, which is scheduled for June 6, 2022;
4. Defendants/Respondents, the 22<sup>nd</sup> Ward Democratic Executive Committee, including its current Ward Leader Cindy Bass, shall fairly distribute to all duly elected 22nd Ward Committee persons the normal election paraphernalia that is normally accorded to its members consistently with the operational rules of the Commonwealth of Pennsylvania and County of Philadelphia Democratic City Committee;
5. Defendants/Respondents, the 22<sup>nd</sup> Ward Democratic Executive Committee, including its current Ward Leader Cindy Bass, are encouraged to apply and govern with the referenced *Robert's Rules of Order* to conduct its meetings and to encourage civility among its members;
6. All duly elected 22nd Ward Democratic City Committee members are strongly encouraged to be civil and respectful of differing viewpoints of other members;
7. All duly elected 22nd Ward Democratic City Committee members are strongly encouraged to accept mediation intervention, either from Democratic City Chairman Robert A. Brady or someone of equal measure and expertise, to resolve the ongoing disputes and to avoid the necessity of judicial intervention in the future.
8. The instant Order is a Temporary Order that is effective immediately and shall remain effective until further Order of Court.
